The first sentence of Paragraph (a), Clause I-112, is revised to read as follows: "(a) the amount presently obligated by the Government with respect to this contract is **\$19,943,028,517.77** through modification **692**.

The funds obligated by this action represent a net funding increase of **\$38,588,610.11**. The total amount now obligated by the Government with respect to this Contract is **\$19,981,617,127.88**. The Approved Funding Programs **53 and 54, Part 2** are hereby incorporated by reference. The funding shall be distributed into the Obligation Control Levels as specified in Approved Funding Programs **53 and 54**.

In accordance with Clauses B-2, the Contractor is authorized for the period of October 1, 2018 to September 30, 2019 to withdraw in monthly installments and on the last day of each month, 1/12<sup>th</sup> of the annual Fixed Fee. The annual Fixed Fee amount is \$12,952,783.00. Additionally, the Contractor is authorized for the period of October 1, 2018 to September 30, 2019 to withdraw in monthly installments and on the last day of each month, 3% of the annual Maximum Available Performance Incentive Fee. The annual Maximum Available Performance Incentive Fee amount is \$30,223,159.00. Finally, the Contractor is authorized for the period of October 1, 2018 to September 30, 2019 to withdraw monthly installments and on the last day of each month, 1/12<sup>th</sup> the Maximum Available Fixed Fee collected from Reimbursable work. The estimated Maximum Available Fixed Fee from Reimbursable work is \$7,548,000.00 based on an estimated cost of \$301,912,000.00. The Transition Period was performed on a cost reimbursement no fee basis for the period of May 9, 2007 to September 30, 2007 and final payment was made on modification 206. The Transition Period is now closed.
