The contract is extended from September 30, 2015 to September 30, 2016 as a result of earning an Award Term in performance year FY 2010.

The following changes are hereby incorporated into the contract:

1. Clause B-2 is changed as follows:

Paragraph (b) the title is changed to delete "Estimated Cost for the" and the title now reads "Contract's Transition Term."

Paragraph (b)(1) the title is changed to delete "Estimated Cost for the" and the title now reads "Transition Term of the Contract is:"; the transition cost ceiling column heading is changed to "Final Cost" and the amount in the column is reduced from \$10,128,270.00 to \$10,097,432.78 based on Modification 206.

Paragraph (b)(2) the following sentence is added after "basis." The Transition Period is now closed. Final cost and payment was made on Modification 206."

Paragraphs (d) (2) and (3) are changed to add the second earned award term period of 01Oct15 to 30Sep16.

Paragraph (e) (2) is changed to add the second earned award term period of 01Oct15 to 30Sep16.

Paragraph (h) the accounting and appropriation data is changed from \$828.79 to \$365,000 and from \$205,000 to \$174,157.78 to bring the appropriated total to the final cost amount of \$10,097,432.78.

2. Clause B-9999 is changed to add the funding reductions for work authorizations LLNL-10-FEW173 and AT/NS50/10/ARRA-2; and to add a no cost time extension for work authorization KJ/NS50/0/ARRA Rev 2 issued in Modification 231.

3. Clause F-2

Paragraph (a) (2) is changed to add after "30Sep2015);" "earned award term (01Oct15 through 30Sep16);"

Paragraph (b) is changed to delete "2015" and replace with "2016".

4. Clause G-1 paragraph (b) is changes to delete "Service Center" and replace with "Albuquerque Complex".

5. Clause H-6 is changed as follows:

Paragraph (d), the table is changed to add the actual costs of "\$1,526,147" and Mod# "232" to the contract period 10/01/2009-09/30/2010 and to add the earned award term contract period of "10/01/2015-09/30/2016".

6. Clause H-8 is changed as follows:

Paragraph (b) (1), the table is changed to add the actual costs of "\$282,026" and Mod# "232" to the contract period 10/01/2009-09/30/2010 and to add the earned award term contract period of "10/01/2015-09/30/2016".
